In pursuance of Order No. 320-PLB (Dte.) /RKVY dt. 14.11.2012 of the undersigned, an amount Rs.9.697007 crore (Rupees Nine Crore sixty-nine lakh seventy thousand seventy) only has been drawn by the Joint Director of Agriculture (Accounts), Directorate of Agriculture, Writers' Buildings towards implementation of different sub-schemes [(1A) to 1(D)] of Stream-II project " (1) Facilitation of Agricultural Extension & Mass Campaign" under RKVY during the year 2012-13.


2. Out of above fund of Rs.9.697007 crore an amount not exceeding Rs. 4.18038 crore (Rupees Four Crore Eighteen lakh Three thousand Eight Hundred) only is, hereby, released to the concerned Officers of this Directorate as per Annexure-I for incurring expenditure towards "(1B)- Mobility Support to Extension Functionaries (i) for Asstt. DA (Blocks), (ii) for Asstt. DA (Admn.) of Sub-division, (iii) for DDA (Seed Cert.), WB & Asstt. DA (Admn.), Seed Cert. of 4 regions, (iv) for 8 Agril. Res.Stations" under Stream-II projects of Agriculture Department under RKVY during the year 2012-13.

3. The Joint Director of Agriculture (Accounts), Director of Agriculture, Writers' Buildings will disburse the fund to the concerned officers through RTGS/ Account Payee Cheque/ Bank Draft, as the case may be, as per Annexure-I enclosed.

4. The officers mentioned in Annexure-I will receive the fund and implement the above approved schemes for which fund is released and placed at their disposal as well as will incur expenditure observing existing financial rules and norms of the Govt. taking into account the expenditure break up & purposes as stated in Annexure-II enclosed.
