NOTIFICATION

In pursuance of Finance Department's Memo No. 6075-F, dated 21/06/1990 and 3015-F, dated 13/03/2001 regarding Career Advancement Scheme, the 9 (Nine) Officers borne under West Bengal Agricultural Service (Administration) Cadre who had completed eight years of continuous and satisfactory services in the Scale of Pay of Rs. 8,000-275-13,500/- and its corresponding unrevised Scale taken together, without any promotion in their career, were granted the next higher scale (1st higher scale) of pay of Rs.10,000-325-15,525/- under W.B.S. (ROPA) Rules, 1998. Now, as the said 9 (Nine) Officers have completed total sixteen years of continuous and satisfactory services with one advancement under MCAS'2001 without any promotion since their joining in the W.B.A.S. (Administration), they are entitled to move to the Second Higher Scale of Rs. 12,000-375-18,000/- (pre-revised Scale No.18) and its corresponding revised Scale of Pay of Pay Band-4B, i.e. Rs. 28,000-52,000/- + Grade pay of Rs. 7,600/- read with No. 961-F (P) dated 07.02.2011 under Modified Career Advancement Scheme, 2001.

Now, in pursuance of Para 3 (i) of Finance Department's Memo No. 3015-F, dated 13/03/2001 regarding Career Advancement Scheme, the Governor has been pleased to order that the 9 (Nine) Officers borne under W.B.A.S. (Administration) Cadre as per enclosed list, who have completed 16 (sixteen) years of continuous and satisfactory service with one advancement in the pre-revised Scale of Pay of Rs. 10,000-325-15,525/- (Scale No. 17) and its corresponding revised Scale of Pay of Pay Band-4 i.e. Rs. 9,000-40,500/- + Grade Pay of Rs. 6,600/- p.m. taken together without any promotion in the career in W.B.A.S. (Administration), be moved to the next Higher pre-revised Scale of Pay of Rs. 12,000-375-18,000/- (Scale No. 18) under W.B.S. (ROPA) Rules, 1998 i.e. revised Scale of Pay of Pay Band-4B, i.e. Rs. 28,000-52,000/- + Grade pay of Rs. 7,600/-p.m. under W.B.S. (ROPA) Rules, 2009 read with No. 961-F (P) dated 07.02.2011, with effect from the date as mentioned in the enclosed list against each of the incumbents.

These Officers will continue to draw other allowances as admissible in terms of the existing Government orders in addition to their respective pay in the pre-revised Scale No. 18 and its corresponding revised Scale of Pay of Pay Band-4B, i.e. Rs. 28,000-52,000/- + Grade pay of Rs. 7,600/- p.m. under W.B.S. (ROPA) Rules, 2009 read with No. 961-F (P) dated 07.02.2011, which are being allowed to them with effect from the date as mentioned in the said list against each.

3. The charge will proceed against the appropriate Head of Account in the State Budget.


