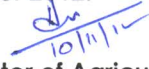

An amount of Rs. 134.50 crore (Rupees One thirty four crore fifty lakh) only has been sanctioned and released vide G.O. No. 10 (Sanction)-Inpt./Ag/P/9M-118/2012 dated 12.11.2012 for implementation of the scheme "Bringing Green Revolution to Eastern India (BGREI)" under RKVY during 2012-13.

2. Out of the total released fund, an amount not exceeding Rs. 53.15 crore (Rupees Fifty three crore fifteen lakh) only is hereby sanctioned & sub-allotted to the officers as stated in ANNEXURE-I towards distribution of **Electric /Diesel Operated Pump Sets and Zero Till Seed Drills** amongst the beneficiary farmers within the BGREI Districts at subsidised rate under the intervention '**Asset Building Activities**'.

4. ORDER

An amount of Rs. 30.00 Crore (Rupees Thirty Crore) only was sanctioned and released vide G.O. No. 36 (Sanction)/AG/O(Inputs)/9M-53/2010 dated 28.03.2011 for the distribution of Pump Sets at uniform subsidy amongst S.H.G/Co-operative Society during 2010-11. Out of the released fund an amount of Rs.24.90 Crore (Rupees TwentyFour Crore Ninety Lakh) only lying unspent in different district accounts.

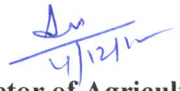

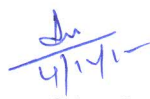
