NOTIFICATION

In pursuance of Finance Department's Memo No. 6075-F, dated 21/6/1990 and 3015-F dated 13/03/2001 & subsequent orders regarding Modified Career Advancement Scheme, '01, viz., 6042-F(P₂) dated 07.11.2019 & No. 5100-F(P₁) dated 31.08.2023 the Governor has been pleased to order **09 (Nine)** officers borne under West Bengal Agricultural Service (Admn.) Cadre, as per enclosure, who had completed eight years of continuous and satisfactory services in the Scale of Pay of Rs. 8,000 - 275 - 13,500/- and its corresponding unrevised Scale taken together, were granted the next higher scale (1st higher scale) of pay of Rs. 10,000 - 325 - 15,525/- under W.B.S. (ROPA) Rules, 1998. Now, as these officials have completed total fifteen (15) years of continuous and satisfactory service with one advancement since their joining in the W.B.A.S. (Admn.), they are entitled to move to the Second Higher Scale of Rs. 12,000 - 375 - 18,000/- (pre-revised Scale No.18) and its corresponding revised Scale of Pay in Pay Band-4B, i.e. Rs. 28,000 - 52,000/- + Grade Pay of Rs. 7,600/- under W.B.S. (ROPA) Rules, 2009 read with No. 961-F(P) dated 07/02/2011, under Modified Career Advancement Scheme, 2001. [Further revised to level 19 under WBS (ROPA) Rules, 2019]

Now, in pursuance of Para-3(i) of Finance Department's Memo No. 3015-F dated 13/03/2001 regarding Career Advancement Scheme, the Governor has been pleased to order that the afore-mentioned officials borne under W.B.A.S. (Admn) Cadre as per enclosed list, who have completed 15 (fifteen) years of continuous and satisfactory service with one advancement in the pre-revised Scale of Pay of Rs. 10,000 - 325 - 15,525/- (Scale No. 17) and its corresponding revised Scale of Pay of Pay Band - 4A, i.e. Rs. 15,600 - 42,000/- + Grade Pay of Rs. 6,600/- taken together in W.B.A.S. (Admin), be moved to the next higher pre-revised Scale of Pay of Rs. 12,000 - 375 - 18,000/- (Scale No. 18) under W.B.S. (ROPA) Rules, 1998 i.e. revised Scale of Pay of Pay Band - 4B, i.e. Rs. 28,000 - 52,000/- + Grade Pay of Rs. 7,600/- under W.B.S. (ROPA) Rules, 2009 read with No. 961-F(P) dated 07/02/2011, [Further revised to level 19 under W.B.S (ROPA) Rules, 2019] with effect from the date as mentioned in the enclosure.

The said officials shall continue to draw other allowances as admissible in terms of the existing Government Orders in addition to their respective pay in the pre-revised Scale No. 18 and its corresponding revised Scale of Pay of Pay Band-4B, i.e. Rs. 28,000 - 52,000/- + Grade Pay of Rs. 7,600/- under W.B.S. (ROPA) Rules, 2009, read with No. 961-F(P) dated 07/02/2011 [Further revised to level 19 under WBS (ROPA) Rules, 2019] which are being allowed to them with effect from the date as mentioned in the said list.

3. The charge will proceed against the appropriate Head of Account in the State Budget.
